

SCOPE OF SERVICES REQUESTED FOR THE ACQUISITION OF PLOT 1296 &1296A IDU INDUSTRIAL AREA ABUJA.

- a. Drawing up a start-to-completion outline of activities and estimated timelines for the transaction.
